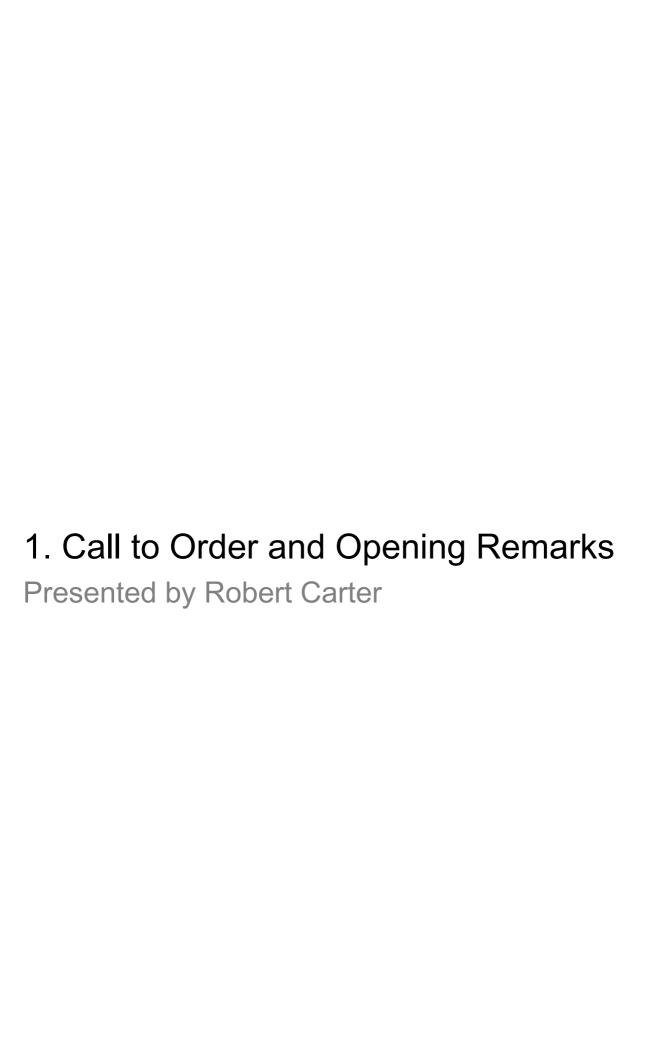

University of Memphis Board of Trustees Advancement Committee Meeting Meeting Minutes September 4, 2024

Agenda Item 1: Call to Order and Opening Remarks

- Trustee Carter called the meeting to order.
- **Trustee Carter** welcomed and introduced members of the Committee, Trustees who are present, and University of Memphis administration.
- Trustee Carter stated that this was the second Advancement Committee meeting. He said the Advancement Committee was off to a great start as a new leader has been put in place, Dr. Tara Jones, who is establishing her team, and that the committee is meeting regularly to look at the all-important topics and impetus behind Advancement and the University.

Agenda Item 2: Roll Call and Declaration of Quorum

- Trustee Carter recognized Board Secretary Colton Cockrum to call the roll.
- Secretary Cockrum called the roll.

Agenda Item 3: Approval of Advancement Meeting Minutes from March 13, 2024

- Trustee Carter called for a motion and a second to approve the March 13th minutes.
- **Secretary Cockrum** called a roll call vote. Trustees Edwards, Carter, and North all assented to approval of minutes.

Agenda Item 4: Advancement Update

- Trustee Carter recognized Tara Jones, Senior Vice President of Advancement
- **Dr. Jones** stated that Advancement ended FY24 with over \$41M raised, which is the second highest total in the last 6 years. The FY25 comprehensive fundraising goal is \$45M, which is the largest goal Advancement has set. She said that the alumni giving rate dropped slightly but noted that research conducted by EAB showed an 11% decline in alumni giving from 2022-2023 across the country. Our endowment fund is trending upward, and the primary way to grow the endowment is through new gifts and commitments. While the Driven by Giving annual campaign had fewer donors in FY24, the average gift size per donor increased. A more proactive approach is planned for FY25. The state

\$50M R1 match opportunity resulted in new endowments for research in FCBE, the Loewenberg School of Nursing, our research department, and others. Of the 19 new endowments that have been established, 13 are fully funded and have produced spendable dollars, which were matched by the R1 program. While there is no deadline for completing the match, it is a priority. We are currently in the silent phase of a comprehensive campaign for the university, which will provide fuel for the Ascend Strategic Plan. Dr. Jones stated that we have raised \$28M towards a \$500M goal. Ideally, we would like to secure 75% of the goal before we publicly announce the campaign.

Agenda Item 5: Additional Business

- Trustee Carter thanked Dr. Jones for her professionalism and organization. He stated that the key to Advancement is connection and communication. If one is connected to the university, they feel empowered and obligated to support the university. Corporations are critical to Advancement, so whatever connections people have with organizations they are a part of, it is important to activate those for Advancement. He said that we need to up the ante for our alumni as well and make sure they are at the table with us and connected to the university. Advancement dollars help fund capital projects for the university, keep operating expenses flowing for the university, and help build the endowment for the university. These are all critical for a thriving university. We need to take advantage of the momentum we have and continue to build on it to develop the university in significant ways. He called out to the Board to be involved and to reach out to organizations and contacts in any way possible to help Advancement move forward.
- Trustee Carter asked for any additional business. There was none.










FYTD25 FUNDRAISING PROGRESS

% of FY25 ELAPSED



FYTD COMPARISON: July - January






GIFT LEVELS – FYTD25

Major Gift \$50K-\$999K


