3.22.11.02 Approval of Agenda

3.22.11.04 Guest Speaker, Joel D. Bumgardner: Safe Zone at U of M

In hopes of securing the body's support, Joel Bumgardner (Biomed Engr), faculty advisor for Stonewall Tigers, delivered a powerpoint presentation to the Faculty Senate describing the Safe Zone program, which some of our peer institutions have implemented. The program aims "to promote and advocate for safe environments respectful of all individuals, including lesbian, gay, bisexual, and transgendered" (LGBT) members of our community. In addition to having a network of volunteers who provide a 'safe zone' on campus for LGBT individuals seeking information and assistance," the program seeks to educate students, faculty, and staff who want to be well-informed allies, on LGBT concerns and related issues. Due to time constraints at the meeting the Faculty Senate will vote on supporting or not supporting this program at its next scheduled meeting.

3.22.11.05 Guest Speaker, Danita A. Macon: New Campus email Provider

Danita A. Macon, Director of Enterprise Infrastructure Services [InformationTechnology], explained that in light of the current and future budget constraints on the U of M, as well a evolving industry options for email services, two email evaluation teams---one consisting of students, the other of staff and faculty---to address the question of whether the U of M should continue to manage and house its email internally or look for a cloud provider as an alternative. The teams administered surveys, interviewed vendors, demoed and evaluated products, reviewed references, and analyzed the cost options. Based on functionality, vendor support, ability to provide services, ease of transition, higher education references, security and cost, the recommendation for both teams was that we move to the Microsoft Live@edu.solution, and have it in place by the start of the Fall 2011 semester. This migration of services will not affect our current email addresses.

3.22.11.01 President's Report

- 1. <u>Administrative Council Meeting, March 2, 2011</u>: The focus again was the formula for funding each state institution of higher learning, with graduation rates heavily weighted and it being "a zero sum game."
- 2. <u>Faculty Evaluation of Administrators</u>: The evaluation of university administrators (President, Provost, and Deans) will be conducted again this spring so as to provide faculty feedback from which administrators might profit. A motion from the EC to conduct the survey was brought before the full senate.
- 3. Other: It appears that Tennessee state employees will receive a 1.6% raise in the next fiscal year. Legislators are still exploring the options for where the money will come from.

3.22.11.07 New Business

Motions from the Executive Committee to the Senate:

1. Move that the Faculty Senate elect Wade M. Jackson to replace the vacancy left by Edward H. Perry's resignation from the Faculty Athletics Committee.

Adopted by unanimous voice vote on March 22, 2011.

2. Move that the Faculty Senate ratify the appointment of Wade M. Jackson's to serve on the Strategic Planning Facilitation Committee. This motion was amended to place a two-year time limit on the appointment. It passed as amended with one nay.

Adopted by voice vote with 1 nay on March 22, 2011.

3. Move that the Faculty Senate again provide its constituents with an annual survey to evaluate the performance of our administrators (President, Provost, Deans). To accommodate colleagues who want to make their comments available only to those whom they are evaluating and not to the general public, a mechanism will be included this year to give them this option. The numerical results will still be available to everyone.

Adopted by voice vote with 1 abstention on March 22, 2011.

Faculty Policies Committee motion for Online Voting: The motion concern a new process for amending the Constitution. The Online Voting rationale and motion are attached in its entirety. Motion to the Senate: The Senate must vote on the new amendment(s) at the first meeting following the second meeting of the Faculty Policies Committee after the online voting. The Senate may amend the new amendment(s). The Senate will recommend to either accept or reject the new amendment(s). The new amendment(s) will be passed on to the University Faculty along with senate recommendations for online voting following the rules stipulated in Step D of this Section. The second round of voting will be preceded by a 2-week online, public, and non-binding, discussion period.
