<u>Faculty Policies Committee Motion</u>, Process for Modifying the Faculty Handbook (see attached) Rationale

The process for modifying/updating the Faculty Handbook needs to be defined so that transparency is maintained.

Motion to the Senate

The Senate recommends the Faculty Handbook be modified to include the new modification process developed by the Faculty Policies Committee.

The attached motion has been modified to accomplish ONLY the process for modifying the handbook, which has been agreed upon by Ann F. Harbor, Dir., Admin. Academic Affairs (Provost Office).

The agreed process is as follows: The current changes to the Faculty Handbook will be identified by highlighting the affected portions of the text for one year.

Prior changes will be listed by date on a revision page which will be located prior to the Table of Contents, describing the location of the change.

The color highlighting of the changes made in any given year will remain intact in the archive of that year's Faculty Handbook.

Past and current Faculty Handbooks (with or without highlighting) will be archived by the Director of Academic Affairs Administration and will be available electronically via the internet at the University of Memphis. So the process will simply need to be given to the new Faculty Policies Committee for review and introduced to the Faculty Senate at its meeting for approval.
