04.27.10.10 President's Report

<u>TBR Faculty Subcouncil Meeting (April 16, 2010)</u>: This meeting was uneventful except for a vote approving an articulation core for psychology.

Provost Funding Formula Meeting: In facilitating discussion of The Tennessee Higher Education Commission's (THEC) new formula for funding state institutions based on weighted subpopulations, the provost provided reports from the university's OIR (Office of Institutional Research) on (1) the number of graduates in 2008-2009 in the sub-populations discussed by the group, and (2) graduation numbers of some of these sub-populations. Based on the provost committee's discussion, the four groups the U of M selects should probably be Low Income students, Underrepresented Minority students, First Generation college students, and Adult students. The first three are clear choices at this point, and the provost does not think that the transfer category will be eligible. Several present had reservations about the male category. Although we do not have the graduation rates on the Adult group, there is strong indication that their impact will be greater than the male group.

On the ordering of the categories to determine the weights, the provost is inclined to go with the order of:

- 1. Graduate Degrees
- 2. Undergraduate Degrees
- 3. Research
- 4. Degrees per FTE
- 5. Transfer Activity
- 6. Student Retention

Meeting with President Raines: The smoking ban was the only item discussed.

<u>Marcus Orr Lecture Funding AY 2010-2011:</u> We have no assurance that there will be funding for a lecturer next year.

<u>New Senate Chambers in New Student Center:</u> We can expect to meet in the new senate chambers next fall. The Senate Chamber, room 261 is located on the second floor of the University of Memphis new University Center.

04.27.10.11 Past-President's Report

- 1. <u>Revision to Policy UM1564</u>, <u>Grievance Process and Conflict Resolution</u>. The FS asked that the faculty members who sit on this committee be selected by the FS, not by administration. Although President Raines had concerns about such a procedure, a compromise was reached: FS will come up with a pool of names from which the administration will fill the position. This procedure will be in the Faculty Handbook, and David Cox in the President's Office is working on a comparable statement to include with the university's other policies.
- 2. <u>Policy Statement on Chair Selection</u>. FS asked that, except in unusual circumstances, successful chair candidates must have the support of a majority of their faculty. FS wants this to

be a university policy statement, not part of the Faculty Handbook. The issue remains unresolved.

- 3. <u>Untenured Faculty Appeals of Annual Evaluations</u>: The FS has pushed to have the word "tenured" removed so as to include all faculty in the appeals provision. So long as the statement makes it clear that faculty will not be retrying old facts but appealing only the process, David Cox, representing the President's Office, believes this change will go through as acceptable to all parties.
- 4. <u>FS's Role in New Faculty Orientation.</u> The Faculty Senate will have a role in New Faculty Orientation this fall. This will allow our president, W. Jackson, to convey our concern for our new colleagues' interests by letting them know of the mechanism for getting their first paychecks earlier than they would normally.
