2.21.12.04 Invited Guest: J.A.M. "Toby" Boulet, President, TN University Faculty

Senates (TUFS): President T. Boulet provided a power point to familiarize us with the structure, purpose, and methods of TUFS, an organization of which all faculty senates of public 4-year institutions of higher learning in Tennessee are members. Recent activities have included visits by prominent speakers, trips to Nashville to testify before the TN House of Representatives Education Committee concerning Complete College Tennessee Act (CCTA) of 2010, and speaking at a meeting of the THEC Master Plan Committee. Every member campus has a vote in deliberations, and TUFS only acts if all member senates authorize the organization to do so. # 2.21.12.05 Invited Guest: Benjamin Morton, Associate Dean Judicial & Ethical Programs

Dean Morton used hard-copy handouts and power point to familiarize us with his unit's involvement in matters of academic integrity, student behavior in the classroom, and the work of the Behavioral Intervention Team (BIT). He explained the disciplinary procedures have been in the past and the changes that went into effect on January 29, 2012, after being approved by the TBR in December 2011. While the definition of cheating and plagiarism remain the same, the process of handling these cases has been modified so that faculty now have to meet with the students prior to issuing a summary decision or opting to defer to the Academic Integrity Committee (a body composed of both faculty and students). Neither faculty nor department chairs are required to attend these AIC meetings. If the AIC determines there was no academic integrity violation, the faculty member cannot appeal the committee's decision. These changes were mandated by TBR without involving or even informing the Faculty Senate, a troubling lapse that President L. Pivnick called to our attention.

As for the work of the U of M's Behavioral Intervention Team (BIT), faculty should contact them for assistance with concerns about students' erratic, threatening, or otherwise troubling behavior. Dean Morton's position is that faculty have the right to control their space; so if a student comes to class ill, the instructor can require that student to leave. Whereas in the past, the BIT had limited authority, it can now require students to go the counseling center to be assessed. Dean Morton also described what measures are taken to keep our campus safe. ## 2.21.12.06 President's Report

- 1. <u>Faculty Ombudsperson Position</u>: A letter announcing the opening of this position has gone out to faculty. Interested candidates have until March 2 to apply.
- 2. <u>Faculty Handbook (revisions)</u>: A Faculty Senate recommendation, with which the Provost's Office agrees, requires administration to advise the FS by January 31 of any changes they plan to make to the Faculty Handbook. At the end of January 2012, we had been notified of and approved two changes: the process of selecting the faculty Ombudsperson and the statement on academic freedom in shared governance and speech on campus. We were not, however, informed of a third proposed change: the addition of three new categories of faculty: Lecturer appointments; Joint appointments; and Shared appointments. These new designations have been created to handle the special cases of those 18 former Lambuth University faculty who now teach for the U of M. Because we were not involved or consulted, the Faculty Senate agreed to charge the Faculty Policy Committee with looking at this third change.
- 3. <u>Faculty Grievance Committee</u>: President L. Pivnick provided senators with a handout, the fruit of extensive research. In addition to finding a number of different committees that handle faculty grievances, he uncovered an important omission in the Faculty Handbook's section on the President's Hearing Panel. The Handbook fails to state that the Faculty Senate must approve of the list of twenty members, a pool from which panels of four are selected to hear grievances. The Committee on Committees will be charged with repopulating the hearing panel.
- 4. <u>Lounge Committee</u>: This committee has met several times, looked for space both on and off campus, and will be asking President Raines to designate the Bluff room in the University Center as a faculty staff lounge with food service available from 9 am to 2 p.m.
- 5. <u>Common Calendar:</u> The common academic calendar being proposed by Tennessee Board of Regents (TBR) has raised many concerns and has been tabled for now.

#### **2.21.12.07** New Business

- 1. <u>Library Policies Committee Survey (workarounds)</u>: This survey has been sent out, and faculty are in the process of voting.
- 2. <u>Election of a Senator to Committee on Committees</u>: A motion was brought to the floor that the FS approve the nomination of Gloria F. Carr (Nursing) to replace Mark H. Danley (University Libraries) to serve on the Committee on Committees. A voice vote approved it by acclimation.

#### **2.21.12.08** Old Business

<u>Tenure and Promotion Survey Results</u>: Originally, T. Banning, Chair of the senate's Faculty Input Committee was to provide the results of the Tenure and Promotion (T & P) survey however, he escort the TUFS visitor around. W. Jackson present T. Banning's power point showing that faculty voted 2 to 1 in favor of coming up for T & P under the criteria that were in place at the time they were hired. The survey results are as follows:
