4.26.11.08 President's Report

TBR Faculty Subcouncil Meeting (April 22, 2011): This meeting was uneventful.

Incoming President L. Pivnick took a few moments to share his priorities for the Faculty Senate (FS) in the year ahead. He pledged to work diligently for the faculty's academic freedom, job security, job benefits, and increased participation in university governance, as well as for more transparency on the part of administration as the university strives for financial stability and growth. More specifically, he provided the following information to bring new senators up to date:

- 1. <u>The Academic Freedom Policy Amendment</u>: This amendment, which was proposed by the TBR Faculty Subcouncil and all TBR Faculty Senates, would explicitly protect all faculty governance activities by policy, even if the First Amendment does not apply. The TBR attorney, however, is of the opinion that this amendment proposal is unnecessary.
- 2. <u>Faculty Raises</u>: If the state legislature does not fully fund the 1.6% pay raises, the individual schools will have to use E&G (Education and General) Budget funds to make up the difference. Individual universities may award greater salary increases than 1.6% by shifting funds from other sources. Each school, pursuant to a written plan, determines whether funds will be distributed equitably, equally, or meritoriously. The TBR is looking into whether the U of M has a strategic plan for distributing any pay increases.
- 3. <u>Use of E&G Funds for Athletics</u>: The Faculty Senate will continue to oppose giving E&G funds to Athletics at a time when so many critical student and faculty needs are unmet.
- 4. <u>Amendment to FS Constitution and Electronic Voting</u>: To initiate a policy that would let faculty vote electronically on issues that come before the FS, the retiring FS has proposed an amendment to the FS Constitution. It will be brought to the floor at our first Fall meeting. (Postscript: The proposed amendment (online voting) to the Constitution of the University Faculty and Faculty Senate was presented at the fall 2011 General Faculty meeting).
- 5. <u>Financial Transparency</u>: The Faculty Senate's ad hoc Budget & Finance committee (Martha Robinson (Chair), D. R. Jones, Kenneth Lambert, and Craig Langstraat) has been working with the Business & Finance Division (VPresident, David G Zettergren's staff- Deborah Becker and Jeannie Smith) in the preparation of budgets and in increasing transparency by posting budget information on the FS website.
- 6. <u>Tenure & Promotion (T &P) Guidelines in Faculty Handbook</u>: The FS will continue to push for a T&P policy statement that protects candidates from unfair mid-track changes in tenure and promotion criteria.
- 7. <u>Ombudsman</u>: The FS will continue its work to ensure that the duties, selection process, and obligations are well defined.

NOTE: Current law prohibits anyone other than authorized law enforcement officials to bring weapons on campus.
