# 3.26.13.04 President's Report

- 1. <u>Van Share</u>: President T. Banning attended a March 7, meeting at the invitation of David Cox, along with Angela Floyd, Director of Parking & Transportation to hear Michael deVry make his case for the program's benefits. From the faculty's standpoint, the benefits are limited by the constraints of their teaching schedule. DeVry has also met with campus leaders to describe the program's most recent improvements.
- 2. <u>University Web Pages</u>, Faculty Feedback, Prospects for Change (Meeting with Linda Bonnin): President T. Banning met with Linda Bonnin, Vice President for Communications, Marketing, and PR; and Allecia Powell, U ofM webmaster to discuss the new design of the university's website. This meeting focused on faculty complaints about the difficulty of reaching the substantive information they use. Ms. Bonnin told President Banning that over the course of the next nine months the site's interior pages will be redesigned and put into place, and that, in the meantime, some of the problems for faculty have been addressed.
- 3. <u>Faculty Handbook Updates</u>: President Banning again brought us up to date on the arduous process of getting all changes into the 2013 Faculty Handbook through multiple meetings and email exchanges with Mellissa M. Buchner in the Provost Office. As a reminder the changes were: On-line voting (constitutional change), Faculty Ombudsperson (term of office, reporting/accountability) Procedures for Termination (President's Panel), Tenure and Promotion (criteria). The Affiliated Faculty (AF) description is still in negotiation; apparently only one faculty member has been hired in that capacity.
- 4. <u>TN University Faculty Senates general meeting March 22-24</u>: Due to time constraints, this subject will be discussed at the April 16, 2013 meeting.
- 5. <u>Dr. M. David Rudd, Provost</u>: Provost Rudd was present and welcomed by President T. Banning. He was asked to give us an informal sketch of his background and agreed to come back to answer our questions, which we will send him in advance.

## **3.26.13.05** Report of Committee on Committees

1. <u>Tenure & Promotion Appeals Committee (3 positions)</u>: The Committee on Committees chairperson, G. Carr presented the names of these individuals who have voiced an interest in serving and agreed to be nominees for Faculty Senate approval: Brian Janz, (Fogelman College of Business and Finance, Management Info Systems), Ronnie Priest, (College of Education, Health and Human Sciences), and K.B. Turner, (College of Arts & Sciences, Criminology) to serve on the 2013-2014 Tenure and Promotion Appeals Committee.

#### **3.26.13.06** Old Business

1. <u>Living Wage Committee</u>: Asked to clarify this committee's status and function, Senator C. Nordbye first referenced the FS minutes of November 9, 2010 to confirm that our body approved a committee to research the Living Wage issue and give the full senate the benefit of a grounded and cohesive presentation. In concert with FS Committee on Committees Chair Gloria Carr, Senator Nordbye is constituting the study group and urged interested colleagues to make themselves known. Social Work's incoming senator M. Delevage, who was present as proxy for SUAPP (School of Urban Affairs and Public Policy), volunteered to serve on the committee.

#### **3.26.13.07** New Business

- 1. <u>Guest Speakers</u>: Brad J. Frewin, Manager, Physical Plant, Safety & Training, and Fire & Life Safety Inspector, Keith M. Ward, Safety and Training Coordinator, did a power point presentation on the topic: Emergency Preparedness. Mr. Frewin included contact information for this office and distributed the university's Crisis Management Policy For Persons With Disabilities.
- 2. "Calling the Question" per Robert's Rules of Order: In response to concerns several senators voiced after last month's meeting, President T. Banning requested that W. Jackson, senate parliamentarian explain the function of "calling the question" under the terms of Robert's Rules of Order. FS Secretary C. Tucker asked if it wouldn't be helpful to put the item in context and let the record show what had drawn the complaints. C. Nordbye volunteered his perception that it was the cutting off of discussion regarding the motion for equal benefits for employees' samesex partners, an action item that passed at our meeting (an unusually short one) last month.
