4.17.18.02 Approval of Agenda

The agenda was approved with modification to reflect the correct minutes date, March 27, 2018.

4.17.18.03 Approval of Minutes

The minutes for March 27, 2018 were approved as written.

4.17.18.04 Revision to Faculty Trustee Selection With Motions

President Banning reported that after hearing the issues and concerns raised by the full Senate during the March 27, 2018 meeting, the Executive Committee (EC) is offering a revised document on the selection process for the UofM Board of Trustees (BOT) Faculty Representative to be presented, discussed, and voted on today. President Banning yielded the floor to Senator Jones, member of the EC, to begin the process. The revised document and its recommendations were distributed prior to the meeting. See attached for language on motions 1-11.

On behalf of the EC, Senator Jones presented Motion 1. Motion 1 on options adopted by voice vote unanimously on April 17, 2018.

Senator Jones explained the process by which the Senate would vote on motions with options and moved: "The Executive Committee moves that the Senate adopt a special procedure to address the motions which involve options. When there is an option, we will discuss both options first. We will then vote on the first option. If the first option passes, we will not vote on the second option. If the first option fails, we will vote on the second option. If the second option fails, there will be no change in that part of the procedures."

Motion adopted by voice vote with 1 abstention on April 17, 2018.

After the full senate vote to approve the procedure to handle the options, Senator Jones continued on behalf of the EC as speaker to motions 2 thru 11.

Senator Jones presented motion 2 with options. After discussion of both options, Senator Buder moved to amend option 1 to add the word, "contract" before the word position. Amendment to the main motion passed by voice vote on April 17, 2018.

Motion 2, Option 1 adopted by voice vote with 4 nays on April 17, 2018.

Senator Jones presented motion 3. Senator Cohoon moved to amend to remove the words "In addition" from the motion.

Motion 3 adopted by voice vote with 1 nay on April 17, 2018.

Senator Jones presented motion 4. Senator Matthews move to amend to replace a period with a colon.

Senator Schwartzbach moved to amend by adding sentence the "A record of scholarly achievement" as the first bullet point.

Amendment to the main motion passed by hand vote with 23 for and 9 nays on April 17, 2018.

Senator Ozdenerol moved to amend by adding, "an understanding of multicultural, ethnic, gender, diversity, and equity issues." After "Understanding of wider university ..." Amendment to the main motion passed by voice vote with 1 abstention on April 17, 2018.

Motion 5 adopted by voice vote unanimously on April 17, 2018.

Senator Jones presented motion 6. Senator Buder moved to amend to change "expected" to "invited".

Amendment to the main motion passed by voice vote on April 17, 2018.

Motion 6 adopted by voice vote unanimously on April 17, 2018.

Senator Jones presented motion 7.

Motion 7 adopted by voice vote unanimously on April 17, 2018.

Senator Jones presented motion 8 with options. After discussion of the options, Senator Cohoon moved to amend option 1 by adding a comma after the word "forum".

Amendment to the main motion passed by voice vote on April 17, 2018.

Motion 8, option 1 adopted by voice vote with 7 nays on April 17, 2018.

Senator Jones presented motion 9 with options.

Motion 9, option 1 rejected by unanimous voice vote on April 17, 2018.

Senator Buder moved to amend option 2 to change the word "can" to "cannot".
