## 2024 Fall Law Registrar Deadline Calendar

Friday, July 12	<p>eBills available online on <a href="#">TigerXpress</a></p> <p>Students will be notified by email (U of M email address) when eBills are available and by text messaging if signed up on TigerXpress to receive text messages. Official Notifications and viewing eBills available online on <a href="#">TigerXpress</a>.</p> <p>Installment Payment Plan (IPP) available to sign-up on <a href="#">TigerXpress</a>. An initial down payment of 25% of the remaining balance of tuition and fees is required and the \$25 non-refundable enrollment fee will automatically be calculated in the total IPP plan amount. Beginning on August 1, 2024, the non-refundable enrollment fee will be \$50.00.</p>
Monday, August 5 – Friday, August 9	<b>BAPP (Bookstore Advance Payment Plan)</b>
Monday, August 12	<p><b>Deadline to sign up for direct deposit on TigerXpress for processing excess financial aid/scholarship refunds as available for the initial direct deposit.</b></p> <p>NOTE: Students who miss this deadline should still sign up in preparation for subsequent disbursements.</p> <p><b>Initial Fee Payment Deadline (4:30 p.m.) for all registered students.</b></p>
Thursday, August 15	Refunds due from excessive financial aid funds will begin processing for the Fall 2024 term for all students signed up for director deposit.
Monday, August 19	<p><b>First day of classes</b></p> <p>\$200 Late Fee begins for students enrolling in Full Term. Fee will be assessed to all students not paid-in-full or enrolled in the IPP. Late Fee also applies to any initial registrations.</p>
Friday, August 30	<p><b>Last day to add a course</b></p> <p><b>Last day for 100% fee adjustment/refund</b></p>
Saturday, August 30 – Friday, September 6	<b>50% fee adjustment/refund period</b>
Monday, September 2	<p><b>Last day to drop a course without “W” appearing on transcript</b></p> <p><b>Labor Day Holiday</b></p>
