<b>Friday, July 11</b>	<p><b>eBills available online on <a href="#">TigerXpress</a></b></p> <p>Students will be notified by email (U of M email address) when eBills are available and by text messaging if signed up on TigerXpress to receive text messages. Official Notifications and viewing eBills available online on <a href="#">TigerXpress</a>.</p> <p>Installment Payment Plan (IPP) available to sign-up on <a href="#">TigerXpress</a>. An initial down payment of 25% of the remaining balance of tuition and fees is required and the \$25 non-refundable enrollment fee will automatically be calculated in the total IPP plan amount. Beginning on August 1, 2025, the non-refundable enrollment fee will be \$50.00.</p>

<b>Monday, August 11</b>	<b>Fee Payment Deadline for Fall 2025 semester by 4:30 p.m.</b>
<b>Tuesday, August 12</b>	<b>\$200 Late Fee begins for student initial registration.</b>
<b>Thursday, August 14</b>	<p><b>Deadline to sign up for direct deposit on TigerXpress for processing excess financial aid/scholarship refunds as available for the initial direct deposit.</b></p> <p>NOTE: Students who miss this deadline should still sign up in preparation for subsequent disbursements.</p> <p><b>Initial Fee Payment Deadline (4:30 p.m.) for all registered students.</b></p>
<b>Friday, August 15</b>	Refunds due from excessive financial aid funds will begin processing for the Fall 2025 term for all students signed up for director deposit.
<b>Monday, August 18 – Friday, August 29</b>	<p><b>Late Registration</b></p> <p>\$200 Late Fee begins for students enrolling in Full Term. Fee will be assessed to all students not paid-in-full or enrolled in the IPP. Late Fee also applies to any initial registrations.</p>

<b>Friday, August 29</b>	<b>Last day for 100% fee adjustment/refund</b>
