# **Methodist Le Bonheur Center for Healthcare Economics**

**Annual Report for the Period** 

May 2011 - April 2012

May 5, 2012

As in previous years, this year's annual report of the Methodist Le Bonheur Center of Healthcare Economics begins with a description of the mission, history, and objectives of the Center. This is followed by a brief review of a recently completed major research initiative, a comprehensive examination of the impact of national health care reform on health care delivery in Tennessee and in Shelby County, Tennessee. The rest of the report summarizes the Center's specific goals and objectives for the just completed 2011-2012 academic year and our major accomplishments. Finally, the goals and objectives for 2012-2013 are presented.

Mission and Brief History: In March 2003, Methodist Le Bonheur Healthcare, Inc., and the Urban Child Institute (formerly the LHS, Inc.) gave the University of Memphis a donation of \$1.0 million to establish The Methodist Le Bonheur Center for Healthcare Economics (hereafter the Center) in the Fogelman College of Business and Economics. The mission of the Center is to address complex health care issues of efficiency, effectiveness, and equity with a focus on emerging health care issues that affect Memphis, Shelby County, and the state of Tennessee.

**Objectives:** Through a variety of research, instruction, and public service programs, the Center works closely with entities both internal and external to the University to accomplish its mission and objectives. In the near term, the key policy objectives emphasized by the Center will include, among other topics:

- 1. Evaluation of health care programs, such as health care reform, TennCare, and consumer-driven health plans, and the development of strategies and solutions for improving the quality and efficiency of health care delivery;
- 2. Analysis of regional and state health economic trends;
- 3. Assistance to stakeholders such as hospitals, nursing homes, and health plans in developing market analyses and business plans; and
- 4. Dissemination of best practice models to assist employers in the development and implementation of cost-effective strategies for improving employee health and saving health care costs.

**Expertise:** The Center is supported by a superb group of faculty associates who have distinguished themselves in the fields of health care economics and health care administration. These faculty associates are experts in conducting research in a wide range of critical health care issues including:

- Access to health care
- Health insurance coverage
- Health and health care disparities
- Cost effectiveness analysis of health care programs and interventions
- Quality improvement in health care
- Employee health benefits
- Hospital cost management
- Methodological issues in data collection, analysis, and management

# The Impacts of the Patient Protection and Affordable Care Act (PPACA) in Tennessee and Shelby County, Tennessee

The Patient Protection and Affordable Care Act (PPACA) enacted in March 2010 defines a comprehensive health care reform that, once fully implemented, will impact virtually every portion of the health care system. To determine the major impacts of this bold and unprecedented health reform legislation on the health care delivery in our state and in our local community, we initiated a major research program in late 2010. The specific goals were to access:

- 1. the impact of changes in insurance eligibility on the number of uninsured in Shelby County and in the state of Tennessee;
- 2. the changes in health care utilization in the county and state that result from the expanded insurance coverage;
- 3. the impact of reform on health system financing and uncompensated care;
- 4. the economic impact of reform on the overall economy of Shelby County and the state of Tennessee, respectively; and
- 5. the reform's impact on the future manpower needs in Shelby County as well as in the state of Tennessee.

In June 2010, we applied for and received a generous grant from the Memphis Assisi Foundation to support the study of the impacts of PPACA in Shelby County, Tennessee. The results of the research and the final report were completed and released in January 2011 as a joint project with the University of Memphis' Sparks Bureau of Business and Economic Research. To expand the research to the entire state, we applied to BlueCross and BlueShield of Tennessee (BCBST) for funding support and were grateful to receive a generous grant. We were also grateful to the Assisi Foundation for providing another grant to supplement the larger one from BCBST to support this expanded impact study which was completed in January 2012. Both reports have received considerable press attention since their publication in January 2011 and January 2012, respectively. We have subsequently written newspaper op-ed articles in *The Memphis Commercial Appeal* and the Nashville newspaper, *The Tennessean*. We have also met with state legislators in Nashville to brief them on the major findings of the two reports and made numerous presentations to city and county officials and major civic and professional groups including Methodist Le Bonheur Healthcare, The Memphis Medical Society, and the University of Memphis Healthcare Research Journal Club. The reports have also received comments from the Tennessee Health Insurance Exchange, which is the state agency

in charge of the design and planning for the implementation of a Health Insurance Exchange in Tennessee.

### Specific Goals and Objectives for 2011-2012

**Goal 1**: Explore external opportunities

**Objective 1.1** - Promote visibility through outreach and exchange

- The China-Tennessee Exchange Activities
  - <u>City of Chong-Qing</u>: In August 2011, the Center participated in an exchange program sponsored by the Confucius Institute of the University of Memphis that hosted a delegation of administrators and teachers from the central China city of Chong-Qing. Dr. Cyril Chang, the Center's Director, made arrangements for the delegates to visit Memphis hospitals and other health care facilities and gave lectures on American health care and social welfare programs.
  - <u>City of Shanghai</u>: The Center participated in a similar program for more than 25 local administrators and teachers from the city of Shanghai in December 2011.

#### **Objective 1.2 -** Develop collaborative relationships

- Le Bonheur Community Health and Well-Being
  - o In 2010-12, the Methodist Le Bonheur Center for Healthcare Economics became a subcontractor to Le Bonheur Community Health and Well-being, a community outreach division of Le Bonheur Children's Hospital, under a multi-site, federally-funded project, the Nurse-Family Partnership Program. The Center's role in this partnership is to track and analyze the costs of this well-known, evidenced-based intervention program designed to improve the health outcomes of at-risk infants and their first-time mothers.   - Dr. Cyril Chang, the Center's Director, and the Center's research associates worked in concert with Ms. Renee Frazier, the Executive Director of the Healthy Memphis Common Table, and her staff on a variety of communitywide health care initiatives. The focus of 2011-12 was to establish baseline

health status metrics and engage stakeholders from the purchaser, provider, and health plan communities in coming together to improve the quality of health care at the community level. Contact person: Renee Frazier, Executive Director, Healthy Memphis Common Table.

#### Methodist Le Bonheur Healthcare

- O Action: Worked closely with the Corporate Office of Methodist Le Bonheur Healthcare, Le Bonheur Children's Medical Center, and Methodist College of Nursing in providing expertise and technical assistance on a wide range of research and operational issues and projects.
- Result: The collaboration resulted in the following tangible outcomes:
  - 1. An economic impact study of a proposed change in TennCare reimbursement policy that could severely affect TennCare payments to Le Bonheur Children's Hospital and the Memphis regional economy;
  - 2. Consultation service to Le Bonheur Children's Medical Center in its effort to win a U.S. Department of Health and Human Services grant to provide home visitation services to at-risk mothers;
  - 3. Technical assistance to the Methodist Le Bonheur Corporate Office in connection with its evaluation of a faith-based community outreach program.
  - 4. Participation in the preparation of a corporate strategic retreat to assess the impact of health care reform.

- **Objective 3.1** Engage in collaborative research and service activities with health-related units/departments across the University of Memphis campus to promote engaged research

- Action: Built on the momentum from previous years, The Healthcare Economics Center continued to organized and held monthly interdisciplinary research seminars under the funding support of Health Care Research Journal Club.
  - <u>Result</u>: A total 6 well attended seminars were held in 2011-2012. Topics ranged from physician behavior change to hospital strategic response to health care reform, and to patient-centered medical homes. The seminars also provided a forum for health care practitioners and university researchers to network and exchange ideas.
- Action: Provided planning and design support for the proposed School of Public Health at the University of Memphis. Worked closely with the faculty and administrators of the School of Public Health in assisting its growth and development.

<u>Results</u>: Participated in the design and development of the Ph.D. program in Health Services and System Research and the recruitment of 3 new faculty members. Co-sponsored external speakers to visit the University of Memphis and address faculty and graduate students.

Action: Worked closely with Dr. Andrew Meyers, Vice Provost for Research, and Dr. David N. Cox of the President's Office in seeking funding and in-kind support from Methodist Healthcare and the Urban Child Institute for health-related research activities and projects for faculty and students of the University of Memphis.

- Dr. Cyril Chang serves on the Board of Directors of QSourceAR<sup>TM</sup>, a fully owned, non-profit subsidiary of QSource TM Tennessee. QSource AR<sup>TM</sup> and QSource TM Tennessee are both organized as nonprofit centers for health care quality improvement. QSource TM Tennessee is also officially recognized as a Medicare Quality Improvement Organization (QIO) for Tennessee.
