## **Methodist Le Bonheur Center for Healthcare Economics**

**Annual Report for May 2016 - April 2017** 

June 15, 2017

As in previous years, this year's annual report of the Methodist Le Bonheur Center of Healthcare Economics (MLCHE) begins with a description of the mission, history, and objectives of the Center. The rest of the Annual Report summarizes the Center's specific goals, objectives, and major accomplishments for the just completed 2016-2017 academic year. Finally, the goals and objectives for the 2017-2018 academic year are presented.

Mission and Brief History: In March 2003, Methodist Le Bonheur Healthcare, Inc., and the Urban Child Institute (formerly the LHS, Inc.) gave the University of Memphis a donation of \$1.0 million to establish The Methodist Le Bonheur Center for Healthcare Economics (hereafter the Center) in the Fogelman College of Business and Economics. The mission of the Center is to address complex health care issues of efficiency, effectiveness, and equity with a focus on emerging health care issues that affect Memphis, Shelby County, and the state of Tennessee.

**Objectives:** Through a variety of research, instruction, and public service programs, the Center works closely with entities both internal and external to the University to accomplish its mission and objectives. In the near term, the key policy objectives emphasized by the Center will include, among other topics:

- 1. Evaluation of health care programs, such as health care reform, TennCare, and consumer-driven health plans, and the development of strategies and solutions for improving the quality and efficiency of health care delivery;
- 2. Analysis of regional and state health economic trends;
- 3. Assistance to stakeholders such as hospitals, nursing homes, and health plans in developing market analyses and business plans; and
- 4. Dissemination of best practice models to assist employers in the development and implementation of cost-effective strategies for improving employee health and saving health care costs.

**Expertise:** The Center is supported by a superb group of faculty associates who have distinguished themselves in the fields of health care economics and health care administration. These faculty associates are experts in conducting research in a wide range of critical health care issues including:

- Access to health care
- Health insurance coverage
- Adoption and use of eHealth by providers and mHealth by consumers
- Health and health care disparities
- Mental health and opioid abuse
- Cost effectiveness analysis of health care programs and interventions
- Quality improvement in health care
- Employee health benefits
- Hospital cost management
- Methodological issues in data collection, analysis, and management

## Specific Goals and Objectives of MLCHE for 2016-2017

## **Goal 1**: Explore external opportunities

**Objective 1.1** - Promote visibility through outreach and exchange

- Methodist Le Bonheur Healthcare:
  - Collaborated with Methodist Le Bonheur Healthcare (MLH) by providing expertise and technical assistance on projects of mutual interest. Specific projects included:
    - Worked collaboratively with MLH's community outreach division, the Methodist Le Bonheur Community Health and Well-Being, on a variety of projects including a newly initiated asthma prevention programs under the joint sponsorship of Le Bonheur Children's Hospital and the nationally known Green and Healthy Homes Initiative.
    - Analyzed the health and financial implications of Governor Haslam's
      Insure Tennessee Program and evaluate the arguments for and against
      this market-driven alternative to the Medicaid expansion program
      under the Affordable Care Act (ACA).
    - Offered expertise and advice on the ongoing effort at Methodist to transform its primary care practices into NCQA recognized Patient Centered Medical Homes.
    - Worked closely with physician and non-physician researchers on innovation projects for potential submissions of research proposals.
    - Provided consultation service and offered expertise to the Corporate Office of Methodist Le Bonheur Healthcare on a wide range of business and economic issues
- Common Table Health Alliance (CTHA)
  - Worked closely with CTHA in developing and maintaining projects of mutual interest. Contact person: Dr. Barry-Lewis Harris, CEO of CTHA
  - Provided data and analytical support for the various community-based projects that promote efficiency and health care quality.
- Tennessee Department of Health
  - Or. Cyril Chang participated in the establishment and growth of a newly established Tennessee Health Economics Consortium in 2016 under the auspices of the Tennessee Department of Health (TDH). The overarching purpose of the Tennessee Health Economics Consortium was to assist TDH in incorporating basic health economics into public health strategic planning and decision making to improve efficiency and quality of program outcomes.

- One of the immediate projects the Consortium was a health economics workshop offered to senior staff members and analysts of TDH in March 2016 to acquaint them with basic health economic concepts and applications of them to public health issues and programs. Another highpriority project was to assist the Commissioner of TDH, Dr. John Dreyzehner, in the development a job description and a recruitment plan to hire TDH's first Senior Health Economist.
- O The Tennessee Health Economics Consortium met again in November 2016 with Commissioner John Dreyzehner and his health economics staff in Nashville, Tennessee, to review pending projects and to map out a work plan for the near term and identify specific long-term and immediate-term projects of mutual interest.

## Christ Community Health (CCH)

Established and maintained a close working relationship with CCH to explore ways to collaborate on mutually beneficial community outreach projects, with a focus on population health and patient-center primary care.

#### Church Health Center:

- Maintained a working relationship with the Church Heath Center to explore research and community outreach projects of mutual interest.
- University of Tennessee Health Science Center (UTHSC):
  - Worked closely with a wide range of researchers and administrators on a variety of projects including:
    - Provided advice and expertise to the Chancellor's Office of UT Health Science Center on a wide range of strategic and operation issues and challenges.
    - Assisted the Executive Vice Chancellor in the design and planning of an international conference endorsed by Asian Pacific Economic Cooperation (APEC), APEC Regulatory Harmonization Steering Committee, CDC, and major American pharmaceutical companies on pharmaceutical supply chain security.

## **Objective 1.2 -** Develop collaborative relationships

# **Objective 1.3 -** Plan, prepare and submit research grant and service contract proposals for external funding

■ The Urban Child Institute (UCI) of Memphis, Tennessee

## o Actions:

- Following the success of the previous academic year, Dr. Cyril Chang, the Director of MLCHE, continued his service on the Board of the Urban Child Institute (UCI), a charitable nonprofit organization dedicated to the advancement of health and well-being of children in Shelby County, Tennessee, and a strong and sustained supporter of the mission of the University of Memphis.
- Working closely with the UoM Office of Development, Dr. Chang, along with Dr. Stanley Hyland, an Emeritus Professor of Anthropology of the University of Memphis, represented the University of Memphis in the application for funding of \$2 million for supporting several ACE (Adverse Childhood Experiences) prevention research projects, an planning grant for an a altruism research and treatment center, and the creation of a new University of Memphis initiative under the brand name of iIMPACT to coordinate future campus-wide early childhood research. Effort is underway for

continued support for next year's funding needs of the University of Memphis.

#### o Results:

- The University of Memphis was awarded a total of 2 million of research funding support by UCI in April 2017.
- Provided advise and worked closely with UCI in the development of a new 3-year strategic plan.

#### Tennessee Action Coalition

- Action: A proposal was submitted to the Tennessee Action Coalition (\$50,000) to conduct a 3-phase study of the economic impact of expanded practice role of nurse practitioners in Tennessee. The Methodist Le Bonheur Center for Healthcare Economics was awarded \$14,352 for Phase I analysis in September 2015 with Dr. Chang serving as the PI.
- Result: The Center submitted a proposal for \$28,000 to UTK and the Tennessee Action Coalition for Phase II funding and the application is pending.

  - o Result: A service contract under negotiation.

- **Objective 2.2** Prepare and publish in peer-review journals to contribute to the research literature

- O Actions: Purchased jointly with the School of Public Health a large, multi-year hospital dataset, the National Sample of Hospital Emergency Department Dataset, 2012-2015, from the HCUP Project of the federal Agency for Health Research and Quality (AHRQ). The data were acquired for use by health care researchers and graduate students interested in the research of hospital emergency department utilization and cost patterns.
  - Results: The data sets have been installed, cleaned and tested.

- A special workshop was held in the Fogelman College of Business and Economics on 5/13/2015 to exchange research ideas and plan research agenda with about 20 participants in attendance.

- Goal 3: Increase visibility of the Center within the University of Memphis and in the external Memphis health care community
- **Objective 3.1** Engage in collaborative research and service activities with health-related units/departments across the University of Memphis campus to promote engaged research

#### **Actions and Results:**

- Action: Building on the success and momentum from previous academic years, The Methodist Le Bonheur Center of Healthcare Economics (MLCHE) continued to organize and hold monthly interdisciplinary research seminars under the funding support of Health Care Research Journal Club.
  - Result: A total 6 well attended seminars were held in 2016-2017. The first three sessions held in the fall of 2016 were devoted to UT and UoM research projects that had received funding support from the Urban Child Institute. The presenters of three seminars in the spring of 2017 discussed topics ranging from the repeal of ACA to altruism treatment and to community health center. In addition to their education value, the seminars also provided a forum for health care practitioners and university researchers to network and exchange research ideas.

# **Objective 3.2** Provide research opportunities and assist in the development of a richer research environment

 Actions: Serving as a campus resource, MLCHE provided leadership and resources to promote heath care research among faculty researchers and graduate students.

#### Results:

- Provided 3 competitive faculty summer research grants totaling \$23,000 to encourage health care research in the Fogelman College of Business and Economics and the UoM School of Public Health
- Offered travel funds for faculty members and graduate students to attend health care conferences
- Sponsored healthcare speakers for research seminars
- Provided graduate and undergraduate internships to work on health care projects

**Objective 3.3** Serve the external health care community in the greater Memphis area

#### **Actions and Results:**

• In the 2016-17 Academic Year, Dr. Cyril Chang continued his service to the Board of Directors of the Urban Child Institute. He served as a member of the

Board Directors and was active as members of the Institute's Investment Committee that oversaw the management of the Institute's investment portfolio of \$144 million and the Nomination Committee.

**Goal 4:** Promote wellness and health promotion programs for a healthier community

**Objective 4.1** Initiate a wellness research program to gain new research knowledge and contribute to the research literature

#### **Actions and Results:**

- Contacted, met, and discussed projects of mutual interest with researchers with an interest in wellness research from the UoM School of Public Health
- Developed a multi-phase research plan to explore the effectiveness and cost effectiveness of employer-based wellness programs. This far, the efforts have resulted in the development of at least three research papers and the publication of a full-length, original contribution article in a high-impact, top ranked health services research journal:
