

TBI Crime Figures Show Declines in 2024

According to preliminary data from the Tennessee Bureau of Investigation (TBI) released by the University of Memphis Public Safety Institute and the Memphis Shelby Crime Commission, major violent crime, major property crime, and overall crime all declined in 2024 compared to 2023 in both Memphis and countywide.

The major violent crime rate is determined by the number of reported murders, forcible rapes, robberies, and aggravated assaults per 100,000 population. In Memphis, the violent crime rate declined 4.2 percent compared to 2023 and dropped 3.9 percent countywide. This includes significant declines of 29.5 percent in murders in Memphis (28.6 percent countywide) and 22.3 percent in reported robberies (also 22.3 percent countywide). Reported rapes were also down – 8.1 percent in Memphis and 5.2 percent countywide. Reported aggravated assaults remained steady, with a slight increase of less than one percent. (The lack of decline in aggravated assaults kept the decrease in the overall violent crime rate down because aggravated assaults make up about 80 percent of reported major violent crimes.) 

The major property crime rate includes the number of reported burglaries, vehicle thefts, and other felony thefts per 100,000 population. The major property crime rate dropped an encouraging 19.7 percent in Memphis and 19.5 percent countywide. All three categories showed declines. The drop was led by a 37.3 percent decline in reported vehicle thefts in Memphis compared to 2023 and a 35.6 percent decrease countywide. Reported burglaries dropped 19.2 percent in Memphis and 20.4 percent throughout the county. And felony theft offenses dropped 11.0 percent in Memphis and 11.6 percent in all of Shelby County. (This category includes many thefts from vehicle break-ins.)

Reported Major Property Crime January - December


Rate Per 100,000 Population (and Total Number of Offenses)



The overall "Group A" crime rate is determined by the TBI using 54 different types of crime. In Memphis, the overall crime rate dropped 10.7 percent and declined 11.0 percent countywide compared to 2023.

However, reported domestic violence offenses increased slightly in 2024 compared to 2023 – by 2.2 percent in Memphis and 1.7 percent throughout the county. (The aggravated assault numbers include domestic violence aggravated assaults.)

"We should be encouraged by the decreases we saw in most categories in 2024. Overall, the trend is good. As reflected in the 2019 crime data, though, we remain above pre-pandemic levels of major violent crime by a significant degree, major property crime, and the overall crime rate. We have a long way to go to get where we need to be, especially with violent crimes that involve guns," said Bill Gibbons, executive director of the U of M Public Safety Institute and president of the Crime Commission.

"To a large degree, we know what we need to do to keep the encouraging 2024 crime trend moving in the right direction. We must focus especially on the limited number of perpetrators responsible for a large part of our crime either directly or indirectly through their influence over others. We need to scale up intervention efforts to head off retaliatory acts. And we must continue data-driven hot spot policing. If we continue to do these things and do them well, we can drive down crime a lot more," Gibbons added.

About the Crime Statistics: In measuring crime rates and trends, the Memphis Shelby Crime Commission and the Public Safety Institute use primarily preliminary data reported by local enforcement agencies to the Tennessee Incident Based Reporting System (TIBRS), which was developed and is maintained by the Tennessee Bureau of Investigation. An incident is defined in TIBRS as "one or more offenses committed by the same offender or group of offenders acting in concert, at the same time and place." Certain types of violent crimes and domestic violence offenses, however, uniquely refer to a victim count versus an incident count. All rates are calculated based on per 100,000 population.

About the Memphis Shelby Crime Commission (www.memphiscrime.org): The Memphis Shelby Crime Commission is an independent, non-profit 501(c) (3) organization that "quarterbacks" the work of the Safe Community Action Plan. It is funded through the generous contributions of many private sector donors. Ben Adams, chairman emeritus of Baker Donelson law firm, serves as chair of the board, and Bill Gibbons serves as president of the Commission.

About the Safe Community Action Plan (www.memphiscrime.org): Launched initially in 2007, the Safe Community Action Plan, development of which is spearheaded by the Memphis Shelby Crime Commission, is a community-based crime reduction and prevention initiative. The current Safe Community Action Plan (2022-2026) is in its fourth year. Implementation of the Safe Community Action Plan is chaired by Shelby County Sheriff Floyd Bonner.
