The meeting was called to order by President Amy Cable.

Roll call was taken.

A motion was made to approve the March minutes by Hugh Busby and seconded by Joann Waddell. The minutes will be posted to the webpage.

RC Johnson will be our speaker in June. Amy Cable will send an email requesting questions/topics on which you would like him to speak.

Bobby Prince from Development gave an update about the Centennial Anniversary:

- Centennial website will launch at the end of May. It will include centennial stories, looking back, looking ahead, merchandise, major announcements, events, and more.
- Tigers Around Town 100 tiger statues will be placed around town. They will be unveiled 9-10-11-12 (September 10th at Noon).
- Tiger Sculpture Bronze sculpture will be located on the west side of the UC. Your name can be inscribed in proximity to the tiger for a donation as small as \$100. The sculpture will be unveiled 4/20/12.
- A Centennial History of the University of Memphis by Janann Sherman and Beverly Bond will be available for purchase from the bookstore for \$39.95.
- Capital Campaign Overview Began working on the campaign in 2004, will begin the public phase of the campaign September 30, 2011 and will end June 30, 2013.
 - Every gift, regardless of the size or designation, will count towards the campaign.
 However there are three areas of focus: support for students, support for faculty, and support for facilities.
 - o Dollar goal: \$250 million. So far \$163 million in private gifts have been secured.
 - o Planned and estate gifts will be very important to meeting this goal.
 - o "Family Campaign" for staff will begin in May.

Amanda Clarkson from Employee Benefits came to give an HR update:

- To help biweekly employees, HR suggested splitting insurance premiums into two payments, but the state will not allow this. Now we are looking at moving other deductions to the 1st check so that there aren't so many coming from the 2nd check to make them more equal. Senators were asked to share the handout that was provided with biweekly employees in their area so that they can provide HR with feedback. It is important to remember that this is just for feedback, and there may not be any changes made.
- Long term disability meetings are going on today. If you are not enrolled there is an open enrollment period until May 2nd.
- Everyone in the Partnership Plan has until June 30th to complete the wellness questionnaire and screening. The vendor will be here for more screenings next week and again in May and June. Screenings will be by appointment only; they are not accepting walk-ins.
