- Can we expand the parking lots on Zach Curlin? We are currently working on a parking assessment. MLGW owns the parking lots that are on the east side of Zach Curlin, so we can't expand them. We are working on parking enhancements elsewhere on campus.
- Will the city/county merger impact Campus School? Regardless of whether Memphis and Shelby County Schools are merged, there will be little to no change at Campus School.
- Will there be another buy out? Our current financial situation does not permit a staff buyout to be in our foreseeable future.
