IT Presentation on upcoming security initiatives

Network Border Firewall has been implemented on Monday.

Multi-factor authentication – DUO. There is a hard deadline of February 4<sup>th</sup> to be enrolled in DUO. After February 4<sup>th</sup> an individual will be onboarded. Meaning that it will request your information to enroll you into DUO. Multiple ways of using DUO. Cell Phone app, hardline phone and physical tokens. Tokens will be billed by the department, which is \$25 per token. You sign up for DUO in iam.memphis.edu, where you change your password.
