

Tiger Bike Program Terms and Conditions

All participants in the Tiger Bikes Program ("Program") must agree to the following terms and conditions of use and sign a separate indemnification waiver.

Tiger Bikes are available to fee-paying, registered students with valid University ID.

In order to participate in the Program, a student must pay the non-refundable, per-semester fee of \$35 at the time of registration.

Participants understand that Tiger Bikes are allocated on a first-come, first-served basis and that there is no guarantee that a Tiger Bike will be available whenever the participant wants it

Tiger Bikes are available for use for up to fourteen (14) days. At the end of the fourteen-day period, the Tiger Bike must be returned to the Tiger Bike office at 616 Echles and be exchanged for a freshly maintained bike or, if no replacement bike is available at that time, the assigned returned bike will be maintained as the member waits.

Participants who fail to return Tiger Bike/Tiger Bike accessories within the fourteen-day period are subject to pay a late fee of \$10 for the Tiger Bike and \$10 for the Tiger Bike accessories (a combined \$20 when not returned on time) for each and every day past the due date up to the total replacement cost of \$678 for the Tiger Bike_and the Tiger Bike accessories when not returned. These fees will accrue until paid. For convenience, Tiger Bike offers a three (3) day grace period should there be any difficulty returning the Tiger Bike on time. For this grace period to be offered, the Tiger Bike member MUST contact Tiger Bike prior to the bike's assigned return date. After the grace period expires, the above late fees will apply and accrue. The Tiger Bike member must appeal to the Student Business Office to pay any accrued fees. Meanwhile, Tiger Bike will place a hold on the member's bike until proof of fee payment is shared with Tiger Bike.

All Tiger Bikes and Tiger Bike accessories are the property of the University of Memphis and should be treated with care and respect.

A U-lock and cable lock with key will be provided to each participant in the Program when a Tiger Bike is checked out. The participant is responsible for using the lock at all times when the Tiger Bike is not in use. If a participant misplaces the Tiger Bike locks and/or key, or if the Tiger Bike locks and/or key are stolen, the participant should immediately contact the Tiger Bike office at (901) 678-4201 and follow through proper steps to ensuring the security of the Tiger Bike.

A Tiger Bike that is found not to be in proper operating condition may not be ridden and must be immediately reported to the Tiger Bike office at (901) 678-4201. Please report the location and the bike identification name.

Tiger Bike participants may not share their Tiger Bike nor Tiger Bike accessories to non-participants.

Tiger Bike participants will assume personal responsibility for the condition of the bicycle and all equipment that is issued with the bicycle, including, but not limited to: the helmet, rear light, head light, both the U-lock and cable lock, and U-lock key. Tiger Bike participants understand that they may be held liable financially if the bicycle and/or any equipment issued with the bicycle are returned in a damaged state or are stolen.

Tiger Bike participants must follow the rules of the road for cyclists as established by state and local regulations.

Tiger Bike participants understand that there is no refund of membership fees at any time.

The Tiger Bike office is open from 1:00 PM to 4:00 PM weekdays, except on holidays or when the University is closed.

Tiger Bike participants will be provided with safety equipment, including a helmet, taillight, head light, and U-lock and cable lock with key, when checking out a bicycle. Tiger Bike participants are responsible for correctly and consistently using this safety equipment. Any failures in the safety equipment must be immediately reported to the Tiger Bike office.

Tiger Bike participants must take a bicycle security and safety course of approximately thirty (30) minutes prior to being able to check out a bicycle. Tiger Bike participants must be fitted to bike that is correct for their height. Tiger Bikes will not be checked out to any participants that is not deemed safe and/nor the correct size for the participant by the Tiger Bike Shop employees.
